



# Unanimous Vote Establishes Federally Funded Broadband Discount Program

WASHINGTON, February 25, 2021—Today, the FCC voted to formally adopt a Report and Order that establishes the Emergency Broadband Benefit Program, a \$3.2 billion federal initiative to provide qualifying households discounts on their internet service bills and an opportunity to receive a discount on a computer or tablet.

"Today the Federal Communications Commission made history. It adopted rules for the nation's largest-ever program to help households nationwide afford broadband service. This \$3.2 billion program was designed to lower the cost of high-speed internet service for those struggling to get the connectivity they need during the ongoing pandemic. It's a challenge that is all too real for too many families.

"This is a program that will help those at risk of digital disconnection. It will help those sitting in cars in parking lots just to catch a Wi-Fi signal to go online for work. It will help those lingering outside the library with a laptop just to get a wireless signal for remote learning. It will help those who worry about choosing between paying a broadband bill and paying rent or buying groceries. In short, this program can make a meaningful difference in the lives of people across the country. That's why our

work is already underway to get this program up and running, and I expect it to be open to eligible households within the next 60 days as providers sign up and program systems are put in place. I have confidence in our staff that we will do this carefully, swiftly and the right way," said Acting Chairwoman Jessica Rosenworcel.

The Emergency Broadband Benefit Program will provide eligible households with discounts of up to \$50 a month for broadband service, and up to \$75 a month if the household is on Tribal lands. It also will provide a one-time discount of up to \$100 on a computer or tablet for eligible households.

Under the law, the Emergency Broadband Benefit Program is open to households that participate in an existing low-income or pandemic relief program offered by a broadband provider; Lifeline subscribers, including those that are on Medicaid or accept SNAP benefits; households with kids receiving free and reduced-price lunch or school breakfast; Pell grant recipients; and those who have lost jobs and seen their income reduced in the last year.

#### What Is the Benefit?

Up to \$50/month discount for broadband services; Up to \$75/month discount for broadband services for households on Tribal lands; and a one-time discount of up to \$100 for a laptop, desktop computer, or tablet purchased

through a participating provider. The Emergency Broadband Benefit is limited to one monthly service discount and one device discount per eligible household.

# Who Is Eligible for the Emergency Broadband Benefit?

A household is eligible if one member of the household: qualifies for the Lifeline program, including those who are on Medicaid or receive SNAP benefits: receives benefits under the free and reduced-price school lunch program or the school breakfast program, including through the USDA Community Eligibility Provision, or did so in the 2019-2020 school year; experienced a substantial loss of income since February 29, 2020, and the household had a total income in 2020 below \$99,000 for single filers and \$198,000 for joint filers; received a Federal Pell Grant in the current award year; or meets the eligibility criteria for a participating provider's existing low-income or COVID-19 program.

# When Can Eligible Households Sign Up?

The FCC expects the Emergency Broadband Benefit program to be open to eligible households before the end of April, 2021. Please check the FCC's website, www.fcc. gov/broadbandbenefit, regularly for the latest information.

# ST PATRICKS DAY CELEBRATING ON THE AIR

The event runs over the full 48 hour period over the 17th March worldwide, 12 noon on the 16th March to 12 noon on the 18th March UTC.

**SPD Station Award:** To qualify you must be a registered St Patrick Day Station, and have transmitted on the 17th as part of the St

Patrick Award.

**Fixed/Portable Station Award:** To qualify you must make direct two way communication with a minimum of 10 SPD award stations from a fixed location using either mixed modes or CW only.

**Digital Station Award:** To qualify you must make direct two way communication with a minimum of 20 SPD award stations using any digital mode (this includes FT8, DMR, JT65, DStar, Echolink etc.)

**Mobile Station Award:** To qualify you must make direct two way communication with a minimum of 5 SPD award stations from a mobile location using either mixed modes or CW only.

**Short Wave Listener Award:** To qualify you must log two way communications between a minimum of 10 SPD award stations utilizing any mode.

#### OVER NEIGHBORS' OBJECTIONS, SHELBURNE OPERATOR GETS THE **GREEN LIGHT FOR HAM RADIO TOWERS**

Joel Banner Baird - Burlington Free Press SHELBURNE – One-on-one talks with fellow amateur radio operators as far away as Moscow are now firmly on the horizon for a Shelburne man. The erection of two antenna towers on Zachary Manganello's rural property on Dorset Street — a source of contention with his neighbors for at least a year — was approved by the Telecommunications Review Board this week.

On paper, and later, in balloon tests that attempted to approximate the towers' altitude, the structures struck some folks as too tall for the neighborhood.

#### Radio towers downsized

Compromises were struck along the way. The new structures will be measurably less of an eyesore. Originally conceived at 70 feet, Manganello's ham radio project is getting off the ground with slim, guywire-supported towers that extend up 40 and 60 feet. If the towers ever collapse, they'll remain on his lot. If he moves, he'll have to pay for their removal.

Manganello's persistence — and patience — draws on more than a century of niche science. His community of fellow amateurs, also known as "hams," have swapped notes, both casual and urgent, over non-commercial radio frequencies (originally in Morse code) since the 1890s.

Hams tout the technology as a fore-

runner of the internet, and one that still serves to connect, entertain and alert far-flung communities of emergencies when cellphone and broadband service goes down. The FCC takes these hobbyists seriously enough to require them to get licensed.

Shelburne limits such antennae's height to 35 feet in this part of town, which lies roughly equidistant between Spear Street and Hinesburg Road.

#### Ham radio offers backup emergency communication

The prospect of backup emergency communication offered by a local ham radio operator, as well as Manganello's openness to public education and research projects, eventually swayed the citizen-run review board.

So did the Federal Communications Commission, which strongly suggests that local regulators make "reasonable accommodations" to amateur operators — not just for practical reasons, but for "the amateur's unique ability to enhance international goodwill."

Aside from Moscow, Manganello lists Japan and Hawaii as among his over-the-air "targets." And he is an amateur only in the limited, technical sense. Now in his early 40s, Manganello got his first ham license when he was 14, according to his application to Shelburne.

He has held the highest class of

amateur license since he was 17; he is now a card-carrying member of the Vermont Department of Public Safety's Radio Amateur Civil Emergency Service.

"My own technical investigations," Manganello wrote in his application, "have included wireless mesh networking, internet linking, radio astronomy, weak signal propagation evaluation, and antenna design."

The new towers will take about a year to build. They'll have no lights — they lie beneath the FAA's 200-foot threshold for interference with air traffic.

Call sign K1ZK is able to stay on the air if the grid goes down And if the grid goes down in an ice storm? Manganello's in-house station (call sign K1ZK) will, thanks to a solar-charged array and a cluster of Tesla Powerwall batteries, maintain a connection.



Every year we go through the same issue- we don't present a proposed monthly list of presentations and we struggle to come up with a presentation every month. # BRARC Board Meeting Minutes (continued)

#### **New Business**

Website hosting upgrades at the recommendations of John Krupsky (WA5MLF) and Bert Lousteau (K5AJL): (I have taken the liberty of copying John's recommendation to the Board since he wrote it much more succinctly than I could paraphrase).

After some service problems last summer, our hosting service for BRARC.org has been stable in recent times. Several contacts with Godaddy have recommended that we upgrade to a newer plan. This would bring greater reliability, faster performance and better security.

Our current plan, Deluxe WordPress, costs \$167.88 / year (or \$13.99 month). After some hacking problems a few years back we added Website Security Essential for \$83.88 / year (or \$6.99 / mo). The WordPress software dashboard has advised that our version of PHP (5.6.27) is insecure and should be upgraded. Godaddy advised that it cannot be upgraded within our current plan.

The recommended plan is WordPress Ultimate and costs \$215.88 / year (or \$17.99 / mo) if paid for a year in advance. It would renew at \$19.99 / mo afterward. This plan includes the Website Security Essential for no extra cost and also provides an SSL certificate at no cost. The certificate would enable our site to be reached with greater security, using https:// in a visitor's web browser. This prevents web browsers from tagging our site as insecure.

I recommend upgrading our service to take advantage of the benefits described above. Our December 2020 payment of \$167.88 would be applied to the upgraded plan on a prorated basis. Our next renewal for the > \$83.88 Website Security Essential is scheduled for April this year.

Let me know if you have questions or need more information. I have multiple screenshots and invoice copies from Godaddy and transcripts from two recent support chat sessions.

My plan for W5KID.org is to reuse its stranded content in a subdirectory of BRARC.org. Currently W5KID.org redirects to the subdirectory that I designated. To host W5KID.org separately (as it was many years ago) would require either an additional hosting plan or a change to a different plan that would require a lot more work to reassemble the two independent websites.

Dan brought up that he runs his business server at a much cheaper cost and offered to talk with John about an alternative web hosting. John said that he would like to talk to Dan about his internet setup. Jon moved that we look at an alternative web hosting for the club and the Board unanimously agreed. Note that the entire Board agreed to take Dan up on his offer to meet with John and discuss an alternative to what the Board is using at this time. This was not a motion but essentially a consensual agreement.

# **ARISS Columbus Radio System Once Again Operational!**

March 14, 2021—The ARISS Columbus Radio is back on-the-air! This, after it was rendered non-operational following a January 27 EVA (spacewalk) which was conducted to install a cable for the Bartolomeo commercial platform. During the January 27 spacewalk, the Bartolomeo HMU-601 cable, described in the March 10 ARISS Press conference (https://www.youtube.com/watch?v=7hm4h4rBE9k&t=2214s), was installed in series with the ARISS antenna cable (HMU-895).

As part of a spacewalk conducted yesterday, March 13, Astronaut Michael Hopkins successfully completed the installation of three PAPOS connectors for the new Bartolomeo platform on the Columbus Module. After this task, Hopkins started the ARISS task. He moved to the opposite side of Columbus, where he removed the HMU-601 cable from the APCU J02 connector and reinstalled the ARISS antenna cable (HMU-895) connector back into the APCU J02 connector. # Last Man Standing Going QRT


